ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one years or more and citizens of the United States acting as incorporators of a corporation under the Missouri General Not for Profit Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation is Institute for Theological Encounter with Science and Technology (ITEST).

ARTICLE II

The purposes for which the corporation is organized are: (a) to provide a framework within a Christian ethos for professional people and scholars of all faiths concerned with an interdisciplinary search for values in a context of cultural upheaval, (b) to develop an awareness of, and a concern with, rapid cultural change, (c) to communicate such awareness and concern to other segments of the universities, churches, and society, (d) to arrange situations in which methodological approaches may be brought to bear on problems with a theological significance, (e) to establish local chapters under its name and auspices, and (f) to accept gifts and grants, to make disbursements, and to enter contracts

of any kind related to the accomplishment of these purposes.

ARTICLE III

The period of duration is perpetual.
